General training provisions

1. Registration

(a) Order confirmation

Registration for seminars must be made in writing via the registration form. The form filled in and signed by the customer can be sent by email, fax or letter to Business-Logics. The registration is only effective with the order confirmation issued by Business-Logics.

(b) Maximum number of participants

If the maximum number of participants is exceeded for a seminar date, the registrations will be considered in the order of their receipt.

(c) Minimum number of participants

For seminars where the minimum number of participants is not reached, Business-Logics reserves the right to postpone the seminar to the next seminar date. The postponement of the seminar date is notified to the booking contact by email, fax or letter no later than 7 days before the booked seminar date.

2. Cancellation

Confirmed seminar bookings can be cancelled free of charge up to 10 working days before the start of the seminar. Between the 9th and 3rd day before the beginning of the seminar, a cancellation fee of 30% will be charged for each cancelled participant. In case of cancellation of two or less days before the start of the seminar and in the case of non-appearance by seminar participants, the full seminar fee is due. Cancellation fees are not applicable if the seminar is visited by a substitute participant.

3. Services

In addition to the training, the following services are included in the seminar fees: provision of hardware and software, snack or meal at lunch time, drinks.

4. Prices

The prices for the seminar can be found in the application form.

5. Invoicing

The seminar fees will be billed after the seminar. Invoicing is done electronically as PDF file per email. The Invoice is due 30 days after receipt of the invoice without deduction.

All prices are net prices and are charged plus VAT if tax deduction is not applicable under German law. Any transfer fees or bank charges shall be borne by the CLIENT.

6. Travel expenses, allowance

In the case of on-site seminars, travel expenses and allowance of the seminar instructors are not included in the seminar fees. The costs are based on our general price list and will be calculated and marked separately in the written offer.

7. Liability

(a) Participant's knowledge

Business Logics makes a considerable effort to adapt the seminars at the best to the knowledge of the participants. The participants already indicate their respective knowledge at the time of registration (advanced yes/no). Business-Logics assumes no liability whatsoever for consequences resulting from incorrect information regarding the previous knowledge. Also, no liability is accepted for the utilization of acquired knowledge or advice given.

(b) Other exclusions

There is no entitlement to seminars in the event of instructors' illness, force majeure or other, serious and unpredictable events. An obligation of Business-Logics to replace travel, accommodation or other costs is excluded. In general, any liability for indirect damages, in particular for loss of profit or claims of third parties is excluded.

8. Data processing

The CLIENT agrees, that the data transmitted electronically or by other means may be collected, stored and processed by computer systems, or otherwise by Business-Logics for the purpose of concluding and processing this contractual relationship. The CLIENT in particular agrees to receive emails by Business-Logics in the context of electronic invoicing. In all other respects, [our general privacy policy](#) applies.

9. Amendments, scope of other regulations

Amendments and supplements to this contract or conflicting provisions of the CLIENT must be confirmed in writing to be effective. This is also valid for any waiver of the requirement for the written form.

10. Other

(a) Choice of law

This contract is subject to German law. The United Nations Convention on Contracts for the International Sale of Goods is excluded.

(b) Jurisdiction and place of fulfilment

Jurisdiction is Düsseldorf, place of fulfilment is Hilden.

(c) Ineffective clauses, contractual gaps

Should individual provisions of this contract be or become effective in law or unenforceable in whole or in part, the validity of the remaining provisions of this contract shall not be affected thereby. The same applies if the contract contains a regulatory gap.
